ORDER SETTING ASIDE ARREST

THIS MATTER having come before the Court upon the Motion of the Defendant for an Order Setting Aside Arrest pursuant to ORS 137.225, the State of Oregon appearing by and through the District Attorney for Josephine County and the Court having reviewed the records and being fully advised, finds as follows:

1. A copy of the Motion to Set Aside, Affidavit in Support and a complete set of the Defendant's fingerprints, were served upon the District Attorney for Josephine County.
2. The Oregon State Police Bureau of Identification and Information has made positive identification of this Defendant and Defendant is further identified by:

IT IS HEREBY ORDERED that the above arrest be, and the same is, hereby set aside, and for purposes of law the defendant is hereby deemed not to have been previously arrested of said offense;

IT IS FURTHER ORDERED that the arrest is deemed not to have occurred, and the defendant may accordingly answer any questions relating to their occurrence as if it had not occurred;

IT IS FURTHER ORDERED that the record of arrest and any other official records in the case be sealed, including investigation reports of involved law enforcement agencies concerning the alleged criminal episode; and

IT IS FURTHER ORDERED that the Clerk of the Court forward a certified copy of this order to the Director, Bureau of Identification and Investigation, Department of Oregon State Police; the Director, Columbia Region Information Sharing System; the Identification Division, Federal Bureau of Investigation; Grants Pass Department of Public Safety; Josephine County Sheriff's Department; Josephine County Community Corrections; State of Oregon Department of Corrections; and the Josephine County District Attorney's Office.
