SUMMARY

Serves as a sworn Deputy appointed as a Detective to the Illegal Marijuana Task Force. The Detective shall be charged with the duties of investigating marijuana related crimes in and for the State of Oregon and Josephine County.

NATURE AND SCOPE

The Detective is responsible for the efficient and effective investigation of all illegal marijuana related cases assigned to him/her. The Detective works for and at the pleasure of the Sheriff.

ESSENTIAL DUTIES AND RESPONSIBILITIES

(Illustrative Only. Any single position in this classification will not necessarily involve all of the listed duties below and other positions will involve duties which are not listed. These duties represent the essential functions needed of persons in this classification.)

1. Shall arrest, assist in prosecution, or release to the proper agency all fugitives apprehended in the course of his/her assigned duties.
2. Shall be responsible for maintaining sources of information and filing informative reports including such information as may be obtained in regards to suspicious persons or places, occurrences or circumstances that in any way have a bearing on any crime that may be or may have been committed, or which may be of assistance in the solution of any crime, or apprehension of any criminal.
3. Shall maintain a close liaison with Sheriff's Office personnel including cooperative effort with other enforcement agencies.
4. Shall complete all reports in a manner that can be easily read and understood. All reports will be concise, complete and without conjecture.
5. The Detective shall be under the supervision and responsible to the Operations Lieutenant, Undersheriff and Sheriff.
6. Shall, when assigned by a competent authority, assume responsibility for the initiation, execution, and completion of any given assignment not covered under typical duties and responsibilities.

SUPERVISORY RESPONSIBILITIES

Supervision is not normally a responsibility of this position.

QUALIFICATIONS

The Detective shall be a certified patrol Deputy off probation. Be willing to work various hours. Shall be appointed by the Sheriff. To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed are representative of the knowledge, skill, and/or ability required.

EDUCATION AND EXPERIENCE

High school diploma or general education degree (GED); or one to three months related experience and/or training; or equivalent combination of education and experience.

JOB IMPACT

Use sound judgment; make decisions quickly under stressful circumstances and respond appropriately to changing situations and priorities during a shift.

JOB CONTACTS

The position generally has contact with state and federal agencies; community professionals; the public and the news media to receive or provide information. Frequent contacts are made with other governmental agencies, outside agencies and the public.

LANGUAGE SKILLS

Ability to read, analyzes, and interprets general business periodicals, professional journals, technical procedures, or governmental regulations. Ability to write reports, business correspondence, and procedure manuals. Ability to effectively present information and respond to questions from the general public.

MATHEMATICAL SKILLS

Ability to add, subtract, multiply, and divide in all units of measure, using whole numbers, common fractions, and decimals. Ability to compute rate, ratio, and percent and to draw and interpret bar graphs.

REASONING ABILITIES

Ability to define problems collects data, establish facts, and draw valid conclusions. Ability to interpret an extensive variety of technical instructions in mathematical or diagram form and deal with several abstract and concrete variables.

OTHER SKILLS AND ABILITIES

Ability to read, analyze, and interpret Oregon Revised Statutes, technical procedures, and/or governmental regulations. Ability to prioritize and organize assignments. Ability to write reports, warrants and citations. Ability to effectively present information and respond to questions from the general public. Ability to communicate with angry or hostile individuals.

CERTIFICATES, LICENSES, REGISTRATIONS

Must have an Oregon driver's license. Requires successful completion of DPSST Basic Police Deputy Certification within one year of hire. Assigned to Intermediate and Advanced levels upon completion of DPSST certification requirements.

BACKGROUND INVESTIGATION

Those employed in this position are subject to a background investigation. Conviction of a crime will not necessarily disqualify an individual for this classification.

WORK ENVIRONMENT

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. This position works primarily in the field for patrol related duties. While performing the duties of this job, the employee is often exposed to airborne particles; body fluids; chemical solutions; heat; cold; humidity; wet slippery area. The noise level in the work environment is usually loud. This position is impacted by urgent time deadlines, heavy or uncontrollable work flow, hostile customers, the need to make quick decisions, the need for extreme accuracy and attention to fine detail, uncontrollable interruptions and the need to frequently shift attention.

PHYSICAL REQUIREMENTS

The physical requirements outlined are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.
